Online learning or E-learning is one of the ways suggested by related parties to continue the learning system in the current period of time, even though without face-to face learning continues by utilizing technology that has been developed rapidly.

The current learning system really needs a network and even media or tools such as android, laptop or even a notebook and it's really requires more money in this learning process.

The benefit of using synchronous e-learning is there is no isolation from the students which make them is more social or they are felt join as participate in learning process, it was support by Hrastinski, S., (2008: 52). It can be conclude that synchronous e-learning it was take place in real time and use video conference or chat as media as one of interaction or communication between teachers and students also make the students include or join in learning process and there is no isolation between them and make them feel more social than usual.

2. Asynchronous e-learning

Asynchronous e-learning is one of learning process that it is not need time to be present on time or in real time (situation) and it can be done in previous time without presence of teacher or students. In other words this category of e- learning can be done in offline situation.

According to Almosa and Almubarak (2005) in Algathani (2011) stated that asynchronous e-learning do not need interaction in the same time but it was need another time and it was use email or discussion forum as one of media. Similarly Hrastinski (2007) in Hrastinski (2008: 52) said that it was possible for learner or student to log on when learning process at any times and they can be downloading the materials (documents) or they can send message to teachers or their friends.

Based on the explanation above, the researcher sums up that asynchronous elearning need independent and it was need takes place in any time, then e-mail or discussion forum is one of the media that teacher and students apply in e-learning process also allow teacher and students (learners) do discussion among both of them.

### C. Advantages and Disadvantages of E- Learning

There are some advantages and disadvantages of E- Learning that appear in e- learning process.

### 1. Advantages of E- Learning

Based on Smedley (2010) said that e-learning contribute the institution as well as their students or learners be more flexibility of time and place based on the learning information.
